Discussion took place of AFG Yuva Webinar, Saree Walkathon - 1st June, CME on 8th June, cultural with spouse, Walkathon on 29th June BSA

18) Dr. Saurabh Dani raised a query about what would be the area of jurisdiction. It was noted that associate members would not have voting rights. However, they could be included in the Youth Council. This initiative is aimed at increasing involvement.

Dr. Rakesh Pandia stated that the current decisions were taken as there was a desire not to go against the MOGS, and hence it was done accordingly.

However, it was mentioned that this matter can now be revisited in the Constitution Committee as it is purely an education society.

Dr. Arun Nayak explained that AFG was formed as it was difficult for everyone to attend meetings in South Mumbai. A constitution amendment is now required. The role of members not in the defined area needs to be specified. This matter is to be left to the Constitution Committee and everyone agreed to the same. Dr. Rajendra Saraogi mentioned that Youth Council should be incorporated in the constitution.

Dr. Arun stated that before expansion, we should look into the matter of how it will work as it is difficult to collect money for academic activities.
