She further informed that 27 of these applications were received after 1st April 2025, and appreciated President Dr. Nitin Shah for his commendable efforts in encouraging such a large number of new members to join in a short span of time. The remaining 9 applications were initially submitted in 2023 and 2024, but were incomplete. These have now been completed and processed in 2025.

Dr. Nitin Shah informed the Committee that certain updates had been made to the online membership form by Dr. Saurabh Dani, which addressed previous technical issues that members faced while uploading their documents. Rabiya added that, once the form is filled out online, applicants now automatically receive an email requesting them to send the required documents, including their degree and registration certificates. These documents are being collected and systematically stored in the AFG Google Drive, allowing for smooth processing and tracking of memberships.

Dr. Seema Gadiwan suggested that in addition to maintaining digital records, hard copies of all membership documents should also be kept for physical verification and archival purposes. Dr. Nitin Shah agreed with the suggestion and assured the Committee that he would take the necessary printouts and maintain a physical file of the same.

5) Report of FEPPA conference on 19-20 April 2025 CME by Dr Vidya Bandukwala

Dr. Vidya Bandukwala presented a report on the FEPPA CME held on 19th and 20th April 2025 at Ginger Hotel, Andheri East. She shared that the event received an excellent response, with nearly 150 registrations. The CME was organized in collaboration with AFG, and most of the chairpersons were from AFG. The sessions ran smoothly, covering a wide range of relevant topics across both days. The conference also marked the launch of the first session of the Uran Academy, which was very well received.

President Dr. Nitin Shah congratulated Dr. Vidya Bandukwala for curating and conducting an engaging and informative CME. He further acknowledged her efforts in ensuring AFG's dues were honored despite the conference running at a financial loss of approximately Rs.8 lakhs. He noted that although Rs.75,000 was initially committed to AFG, Rs.20,000 was adjusted against MMC expenses, and a cheque of Rs.55,000 was received, which has already been deposited. He appreciated her integrity and dedication.

Dr. Vidya Bandukwala thanked Dr. Nitin Shah for his kind words and support, and added that she believes the team has now gained a better understanding of the system for future planning.

6) Report of 3rd May CME on Key Issues in OBGYN: AFG in association with Mira-Bhayandar OGSMb by Dr Ashok Shukla & Dr Navneet Desai

Dr. Nitin Shah gave a brief overview of the CME held on 3rd May 2025, titled “Key Issues in OBGYN.” The event was organized by AFG in collaboration with the Mira-Bhayandar OGSMb and was attended by approximately 89 participants. The Maharashtra Medical Council (MMC) granted one credit point for the CME.

The event was fully sponsored by Sun Pharma. It featured 3–4 insightful talks by AMC leaders, including a session by Dr. Rajendra Nagarkatti and Dr. Nitin Shah himself. The CME concluded with a productive discussion, and overall, it was considered a successful and well-received event.

7) Report of Physical CME on 18th May Protect & Promote: Cyber Security & Digital Marketing Solutions by Dr Manohar Motwani, DR Saurabh Dani, DR Vipin Checker, Dr Dhaval Belvi

Dr. Dhaval Belvi presented the report on AFG’s unique and multidisciplinary CME, “Protect & Promote: Cyber Security & Digital Marketing Solutions”, held on 18th May at Kandivali. The event was convened by Dr. Manohar Motwani, Dr. Saurabh Dani, Dr. Vipin Checker, and Dr. Dhaval Belvi.

Unlike usual CMEs, this workshop was open to all medical specialties and focused on contemporary non-clinical issues. Key sessions included talks by Rajesh Yadav on hospital setup and Devak Gandhi, founder of Digijar, on digital marketing. Dr. Vipin Checker delivered an engaging talk on cyber security for doctors. This was followed by a workshop on cybercrime by expert Dr. Shekhar Pawar, Director of SecureClaw, and a panel discussion featuring young lawyers from Mira-Bhayandar.

The event saw 133 registrations (both physical and hybrid), and due to popular demand, access to the recording was later opened. The feedback has been overwhelmingly positive.

President Dr. Nitin Shah praised Dr. Vipin Checker as the driving force behind the event, appreciating his efforts in coordinating with speakers and managing logistics despite challenges like last-minute confirmations and ongoing city mock drills. He also acknowledged the valuable contributions of Dr. Dhaval Belvi.

Dr. Bela Bhatt highlighted that participants stayed engaged throughout the event, which reflected the relevance and quality of the sessions.

During our last YUVA webinar, we did not charge any fees for MMC points, and it was free for all participants. However, due to an overwhelming response with over 1000 registrations, we incurred expenses of around Rs.10,000.

To manage such situations better, we have decided to keep a nominal registration fee of Rs.200 for similar occasional webinars. This will help us compensate for the costs involved. We have already secured a sponsorship of Rs.1.5 lakhs for the upcoming webinar, although we will announce the sponsor officially once the funds are received.

Participants who want the MMC point will need to pay this Rs.200 fee. We are planning to offer over 10 MMC credit points this year, so there will be ample opportunities for all. Making every event free with MMC points becomes difficult due to the logistics and cost involved.

However, if required, and if we decide, Rabiya Madam already has the participant list, and we can consider uploading it to grant MMC points free of charge. This can be decided later.

- Semen analysis
- PRP (Platelet-Rich Plasma) preparation

This hands-on display will be particularly valuable for participants who want to understand the **practical execution** of these procedures. The focus of this workshop is to keep the sessions **simple, practical, and clinically relevant**, without excessive theoretical discussions.

After lunch, a **panel discussion** will be held on IUI, designed to provide practical insights into day-to-day challenges and solutions.

In addition Dr. Nitin Shah mentioned The **brochure is ready**, and there has already been **strong interest from participants outside Maharashtra**. To accommodate this, the program will be made **hybrid**, using the **Clirnet platform** for online relays. The hybrid link will be activated two days before the event.

Physical attendance is free for annual members.

Online access via Clirnet will be **chargeable**, even for Mumbai-based members who choose not to attend physically.

This policy follows **Clirnet's guidelines**, and last time even cybersecurity experts confirmed that we must charge for the online link.
