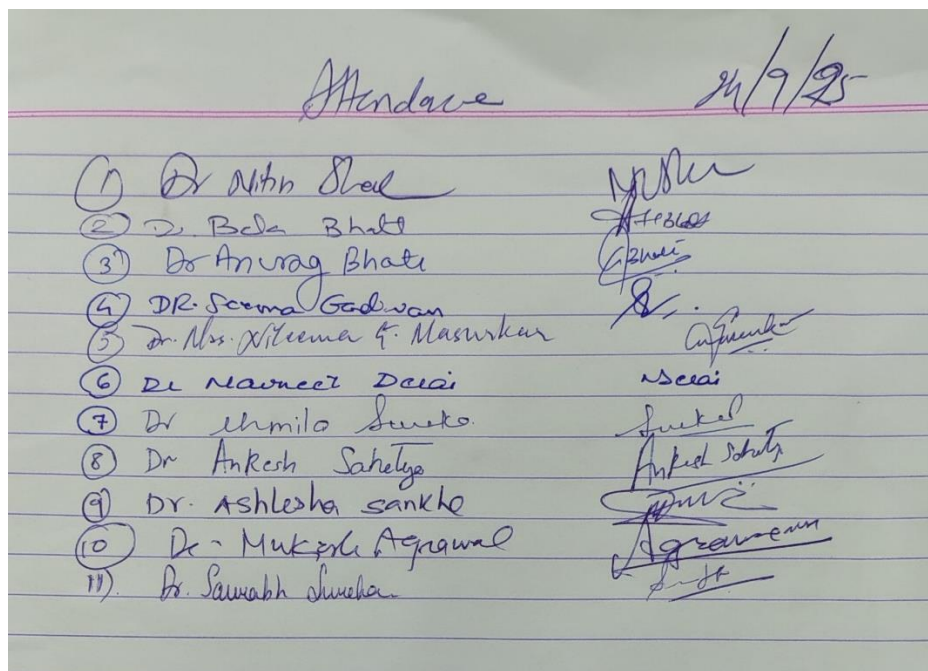

8) In the trust board meeting held on 22/9/25 it was decided that if any losses are incurred in the tenure of any president, he/she will be responsible to clear the losses on his/her own.

The board debated the proposal that any financial loss during the tenure of a president should be borne personally by that president. However, it was agreed that this statement is **too binding, unfair, and impractical**, as the association has earmarked funds and fixed deposits generating regular interest to support activities. Losses, if any, should not be the personal liability of the president alone but must be managed collectively by the committee in consultation with the trust board.

It was further concluded that:

The **wording of Agenda No. 9** will be **rediscussed and reframed** with the Trust Board and the Managing Committee.

A **cap/limit on expenditure** (e.g., Rs.3–5 lakhs) may be introduced, beyond which the president must seek prior approval from the trust board.

Presidents are expected to mobilize sponsorships and funds but will not be forced to pay losses from their own pockets.

The Trust Board may release funds from FDs if there is a genuine financial crunch.

The reframed clause should ensure **financial discipline** without discouraging members from taking up the president's role.

Final Conclusion: Losses will not be carried forward as a personal liability of the president; instead, expenses must be planned, capped, and approved in coordination with the trust board. The clause will be legally reviewed and reframed to reflect shared committee responsibility.
