Additionally Dr. Nitin Shah highlighted that conducting programs at AFG currently results in financial losses. The basic cost of organizing a program at venues like Radisson ranges between **Rs.3.5 to Rs.4 lakhs**, while attendance is typically **50–70 delegates**, making cost recovery difficult.

The association has managed to sustain operations largely due to:

Strong sponsorship support, primarily through personal relationships

Healthium , contributing approximately **Rs.3 lakhs**

Annual memberships, with 94 paid annual members, generating nearly **Rs.7 lakhs**

Digital initiatives, including sale of recorded sessions, contributing approximately **Rs.1.5 lakhs**

Revenue from previous event recordings and digital marketing efforts

It was noted that corporate grants are becoming increasingly difficult to secure, with several committed sponsors backing out at the last moment. Despite efforts to negotiate higher sponsorship amounts, the total grant received remained limited.

Going forward, emphasis will be placed on:

Promoting annual paid membership from Day 1, highlighting benefits such as 12 MMC points

Strengthening digital revenue streams

Optimizing costs while maintaining academic quality

The discussion concluded with the understanding that financial sustainability currently depends heavily on memberships, sponsorship relationships, and digital revenue, rather than event-based income alone.

## 10) Any other matter with the permission of the chair.

Dr. Nitin Shah informed the house about a proposal received from Dr. Hitesh Bhatt, which was earlier discussed during the Medicolegal Conference. The proposal is for **Be Safe Indemnity Insurance**, developed specifically for the benefit of doctors by Dr. Hitesh Bhatt ,Dr Geetendra Sharma in collaboration with Advocate Sushil Gupta (Delhi).

## Association with AFG:

Dr. Bhatt discussed offering a **discount** if a large number of AFG members opt for **Be Safe Indemnity Insurance**.

He also proposed sharing a small percentage of the premium with AFG if members shift collectively.

AFG clarified that it is **not interested in percentage-based arrangements** to avoid bias.

AFG may consider **circulating Be Safe Indemnity Insurance advertisements or details** in member groups, which is felt to be acceptable and non-objectionable.

Members will **not be compelled** to opt for this indemnity; participation will be purely voluntary.

Dr. Saraogi also mentioned that this will be very good for members of AFG & it should be considered positively.

Dr. Bhatt may be given an opportunity to **address members or present details**, at annual conference of AFG and negotiated charges can be shared transparently.
